Constructing Africa's Cities: Labor Market Effects of Infrastructure Construction (2021-2023): This project uses the large-scale construction of Dakar's Bus Rapid Transit system to study the effects of formal-sector employment offers in infrastructure construction. We combine high-frequency data collection on registered job seekers with random arrival of a job offer in the formal sector by a large international construction company to answer two key questions. First, to what extent do applicants take up these jobs and how do applicants who accept offers compare to those who refuse offers as well as those in the control group? Second, what is the effect of the job offer on earnings trajectories, health and future job prospects?

Entrepreneurship Support for Displaced Persons and Host Populations in a Fragile Context (2018-2024): This project aims to generate rigorous evidence on the welfare impacts of entrepreneurship support package for Forcibly Displaced Persons and Host Populations in living in fragile contexts. Using a large-scale field experiment, we assess the socio-economic and psychological impacts of an entrepreneurship

support project which targets forcibly displaced individuals in Niger and the communities hosting them. The study focuses on both economic and psychological outcomes for the beneficiaries of the program as well as community-wide effects.

Leaving no-one behind: using role models to inspire enterprise activity among ethnic minority households in rural Vietnam (2017-2018): This project explores whether shifting mind-sets and aspirations through role models can lead to more enterprise activity among ethnic minorities in Vietnam. The study uses a randomized controlled trial to test whether documentary videos, which tell the story of a successful ethnic minority entrepreneurs who managed to lift their households out of poverty through enterprise activities, inspires others in similar circumstances to do the same.

Site-specific Agronomic Information, Technology Adoption and Farm Productivity: A Field Experiment in Sub Sharan Africa (2017-2020): Design and implementation of a randomized controlled trial of the impact of site specific fertilizer on agricultural productivity. The study also explores the impact of information provision, the provision of credit and insurance against negative shocks on productivity.

NOURISH (2012-2015): Design and implementation of a randomized controlled trial of a range of nutrition and empowerment interventions in HIV clinics in Uganda aimed at changing the behaviour of women living with HIV in relation to nutrition.

So fresh and so clean: urban community engagement to keep streets trash-free and improve the sustainability of drainage infrastructure (2013-2016). Randomized controlled trial of different methods of increasing community engagement in the adaptation to and prevention of flood risks. The study takes place in the context of the World Bank-assisted Stormwater Management and Climate Change Adaptation Project (PROGEP) in Dakar, Senegal.
